SUBJECT - Amendment of the Grant-in-aid Code for Primary Schools - regarding renewal of recognition.

REF: - Letter No.07(5) ದ್ರೋಣ ಅನುಷ್ಠಾನ | 87-90 dated: 2.7.92 of the Director of Public Instruction (Primary Education), Bangalore.

P R E A M B L E:

As per sub-rule (ii) Rule 18 of the Grant-in-aid Code for Primary Schools, the Department (i.e., the concerned Deputy Director of Public Instruction of the District) may at its discretion grant temporary recognition for a period not exceeding one year even when certain conditions are not fulfilled.

2. The Director of Public Instruction (Primary Education) has requested vide letter dated 2.7-92 read at above, to enhance the existing period of renewal of recognition from one year to once in three years as it is a routine affair and will facilitate to reduce the work load in offices of the Deputy Director of Public Instructions and Asst. Educational Officers.
