P R I M A R Y E D U CATION

As per sub-rule (ii) Rule 18 of the Grant-in-Aid Code for Primary Schools, the Department (i.e., the concerned Deputy Director of Public Instruction of the District) may at his discretion grant temporary recognition for a period not exceeding one year even when certain conditions are not fulfilled.

The Director of Public Instruction (Primary Education) has requested vide letter dated 2.7.92 read at above, to enhance the existing period of renewal of recognition from one year to once in three years as it is a routine affair and will facilitate to reduce the work load in offices of the Deputy Director of Public Instructions and Asst. Educational Officers.
