PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: Declaring the Hindi Shikshak Course offered by Karnataka Mahila Hindi Seva Samithi, Bangalore, Karnataka Hindi Prachara Samithi, Bangalore, Mysore Hindi Prachara Parishad, Bangalore, Manasa Education Society, Tumkur, Karnataka Labour Education Society, Bidar, Hindi Shikshana Parangath Course conducted by Government Hindi Teachers Training College, Mysore as equivalent to B.Ed. Course.

Read: 1) Notification No. DPAR 59 SRE 2002, dt. 24-6-2003.

2) Joint Representation dated 31-7-2003 of the Secretary, Mysore Hindi Prachara Parishad, Shivanagar, Bangalore, the Secretary, Karnataka Mahila Hindi Seva Samithi, Bangalore and the Secretary, Karnataka Hindi Prachar Samithi, Bangalore.

3) Subsequent representation dated 4-8-2003 of the General Secretary, Mysore Hindi Prachara Parishad, Bangalore.

4) Letter No. Hindi (Hindi Parangath Pravesha) 04. 2002-03, dated 4-8-2003 of the Director (Urdu and other Minority Language Schools), Department of Public Instruction, Bangalore.

PREAMBLE:

The Karnataka Education Department Services (Department of Public Instruction) (Recruitment) (Amendment) Rules, 2002, as contained in the notifications dated 24-6-2003, read at (1) above, interalia prescribe the qualifications for direct recruitment to the cadre of Language Assistants. The relevant portion of the said amendment rules is quoted below:-

For Language Assistants:-

- a) Must be holder of a Bachelor Degree in arts with the concerned language as one of the optional subjects, namely:- Kannada, English, Urdu, Hindi, Marathi, Telugu, Tamil and Sanskrit or 4 years language Pandit course in Kannada Vidwan in Sanskrit and Urdu Munshi, Examination conducted by the Karnataka Secondary Education Examination Board

AND

- b) Must be holder of a Degree in Education:

Provided in case of a Bachelor Degree holder who has not studied the concerned language as optional subject at the degree level he shall be considered eligible if the concerned candidate-

a) is holder of a post Graduate degree in the concerned language

b) in case of Hindi language Assistant, must be a holder of Bachelor Degree with Hindi as major subject.

AND

Must be holder of degree in Education with the concerned subject or subjects as teaching methods."

Provided further that in case of Language Assistants in Hindi. A Candidate-

- (i) Who has passed Rashtra Bhasha Praveen and Shiksha Snathak (with Hindi and one other language as teaching method) courses conducted by the Dhakshina Bharath Hindi Prachar Sabha and Pre-University course with Kannada or any other regional language as one of the subjects or with Kannada or any other regional language as medium of instruction at P.U.C.level" OR
- (ii) Who possesses any other qualification as may be declared equivalent by the State Government, may also be considered for selection."

2) In the Joint representation dated 31-7-2003 read at (2) above, it has been requested that those who have completed the Hindi Shikshak Course should also be considered for recruitment as Hindi language teachers. Further, in the representation dated 4-8-2003, read at (3) above, the following has been mentioned.

"We express our sincere thanks to you for giving us an opportunity to discuss with you regarding appointment of Hindi Teachers.

After a detail discussion, it was agreed that persons possessing the following qualifications shall be eligible for appointment as Teachers in Higher Secondary Schools:-

1. General Qualification: PUC
2. Hindi qualification: Candidates possessing the following Hindi Degree Qualification with Regional language Kannada as one of the Subjects.
 - a) Hindi Raithna awarded by Mysore Hindi Prachara Parishad, Bangalore.
 - b) Rashtra Bhasha Vidwan awarded by Karnataka Hindi Prachara Samithi, Bangalore.

- c) Hindi Bhasha Praveen awarded by Karnataka Mahila Hindi Seva Samithi, Bangalore.

These degrees are recognised by the State Government of Karnataka and Government of India.

3. Hindi Shikshak Training Course (with Hindi and other Language Kannada or History as teaching methods) conducted by Karnataka Secondary Education Examination Board, Government of Karnataka which is recognised as SECONDARY TEACHER TRAINING COURSE by the National Council for Teacher Education, New Delhi.

4. Must have completed 18 years of Age."

The Director (Urdu and other minority language schools), Department of Public Instruction, has proposed that those, who have completed the Hindi Shikshana Parangath from the Government Hindi Teachers Training College, Mysore may also be considered as eligible for recruitment to the said posts.

3. Government has examined the said representations as well as the said proposal of the Director. Hence the following order;
