

It may please be ensured that all the students who are participating in the School Level Painting Competition and Phase I Essay competition to have an Aadhar number. Heads of the institutes may kindly be advised to instruct the aspiring participants for both events in this regard.

I. Painting Competition:

It is being organized/conducted for the students of 6th, 7th & 8th standards at School Level followed by State Level and finally at National Level in New Delhi. Prize money in cash is given at State as well as at National Level.

II. Essay Competition

It is open to all in the age group up to 18 years as on the date of competition. Prize money in cash is given for the selected essays.

Both the competitions comes under Direct Benefit Transfer (DBT) Schemes, Govt of India

In order to take part in above said competitions, it will be mandatory for the participants to have an Aadhaar

Hence, in pursuance of the provisions of section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) (hereinafter referred to as the said Act), the Central Government hereby notifies the following, namely:-

- (1) An individual desirous to availing benefits under the Scheme shall be required to furnish proof of possession of Aadhaar or undergo Aadhaar authentication;
- (2) Any individual entitled to receive benefits under the Scheme, who does not possess the Aadhar number or, has not yet enrolled for Aadhaar, but desirous of availing benefits under the scheme, shall have to apply for Aadhaar enrolment by 31st August, 2017, in case he/she is entitled to obtain Aadhaar as per the provisions of section 3 of the said Act and such individuals may visit any Aadhaar enrolment center (list available at www.uidai.gov.in) for Aadhaar enrollment.
